TERMS AND CONDITIONS

1. Through its Application, Applicant hereby applies to bluemia, Inc. ("bluemia") and all of its subsidiaries or affiliates, for an open account in the maximum amount of the Credit Amount ("Credit"). Applicant agrees that its credit history and the credit history of any persons listed in this Application (including any Guarantors) may be evaluated by bluemia and/or its agents prior to or during any extension of Credit. Should Credit be denied for any reason, in bluemia's sole discretion, Applicant understands that it has the right to know bluemia rational. Permission is hereby granted to bluemia and/or its agents to verify and/or supplement the information stated herein.

2. bluemia will determine the amount of Credit in its sole discretion, and may raise or lower the amount of Credit, or terminate the Credit, at any time, in its sole discretion. Credit accounts will be charged a monthly finance charge in the amount of 1.5% on all amounts that are past due, which is defined as unpaid within thirty (30) days of due date. All payments made in connection with Credit accounts will be applied to finance charges first and then to any outstanding principal. Any Applicant claims relating to any deficiency in any material provided pursuant to Credit ("Materials") will in no event provide for an offset for any obligations hereunder.

3. If bluemia takes or commences any action and/or hires an attorney to collect any delinquent amounts on Applicant's account (whether or not in connection with Credit), Applicant must pay to bluemia all costs incurred, including, but not limited to, all attorneys' fees, collection agent fees, expert witness fees, other witness fees, and other associated expenses. bluemia may file or commence an action or proceeding in any court of competent jurisdiction which bluemia determines in its sole discretion. The laws of Arizona govern this Application. Applicant understands that it is waiving its rights to litigate outside of Maricopa County, Arizona.

4. Applicant certifies the following: (1) all the information provided in the Application is true and correct and has been submitted to obtain commercial credit; (2) the person signing on behalf of Applicant is authorized to execute applications and other documents required to establish commercial credit accounts on behalf of Applicant; (3) bluemia is hereby authorized to investigate and verify any information provided and to inquire of references or others as to credit worthiness of Applicant or any person listed on this Application; (4) Applicant hereby grants bluemia permission to check Applicant's consumer credit and/or the consumer credit of any of the persons listed in this Application, at any time, for the purpose of establishing or maintaining Credit; (5) bluemia may respond to questions from third-parties regarding Applicant's credit history with bluemia; and (6) Applicant has read, understands, and agrees to all of the terms and conditions contained herein, and agrees to notify bluemia, in writing *via* certified mail, of any material change in name, ownership, location, or corporate status of Applicant within five (5) days of such change.
